### CAFO Update

A 26,000+ hog Concentrated Animal Feeding Operation is still proposed within approximately two miles of Trade Lake. Trade Lake Township is working on an Ordinance to control CAFOs. Burnett County and Lake town Township have passed Moratoriums and are also working on Ordinances. Polk County has developed a pro CAFO group who claim that a CAFO is just another farm and that the area's air and water will not be affected by millions of gallons of hog manure spread across the watershed.

Some beg to differ. KnowCAFOs.org, a local non-profit corporation formed to educate about the truth and consequences of CAFOs, has articles and news updates to help keep everyone informed. In a recent editorial in the Leader, a CAFO supporter attempted to portray anyone involved in protecting the area's air and water as a radical. During the deposition of the CAFO promoter, he made the statement that anyone who opposed the CAFO is a "selfish prick". The pro CAFO group wants to paint the people critical of or questioning CAFOs as opposed to all farming. That is untrue. Appropriate and sustainable farm practices feed the world with healthy food. Please visit knowcafes.org. for more information. There is a long road ahead, but some progress is being made. Trade Lake Township is going to do well testing. Every drinking water well in the Township should be tested. The Association will

email you with the details, but only if there is an updated email on file. In a worst-case scenario, if your well is compromised by chemicals or manure, having a baseline on file will protect your interests. Also, knowing that you are drinking clean water every day is one huge benefit of being near our beautiful lakes.

# A Question of Quality

Our lake association is really concerned with quality; the quality of the water, of the fishing, of the wild, natural feel and views of our lakes. In the case of shoreline quality, we are not neutral, but advocating an aesthetic: "to keep it natural." There are several reasons why.

Mowing your grass down to the shoreline and then wrapping the shore with rocks is antithetical to that natural look, but aids runoff and discourages wildlife. Rock wrappings does require a DNR permit, but the rocks don't have roots nor do they bare flowers and berries. A natural shoreline means having the plants and trees native to our area and you'll still be able to see the water while increasing your own privacy.

There are lots of grasses, shrubs and trees that thrive at the water's edge. Grasses like blue joint grass and all kinds of flowering shrubs like Arrowwood, Chokecherry, Elderberry and the Dogwoods do fine at the shoreline. And many of these plants flower and offer fruit to the birds while holding your shoreline together. There are also trees that do fine with occasional wet feet: River Birch, Willow, Eastern White Pine and Swamp Oak. When you come to the lake, don't spend all your time mowing the lawn and not down to the water. Plant a shrub or a tree to anchor your shoreline.

A full list of these shoreline plantings can be found at the Burnett County web-site left-hand side under "Departments," then "Land Services," then "Conservation Division" and finally "Shoreline Protection." Our local nurseries can help too.

# Memberships and Finances

memberships due, January 1, 2020 regardless of when you paid in 2019, and payable by the 1st of June, 2020. We will be sending out reminders in January, and if required, in May and before the September annual meeting. We will try to incorporate an abbreviated newsletter at the same time. In addition, the by-laws state that dues paying members are the only people who are allowed to vote on anything that comes to the floor, including officer elections.

Membership dues goes toward day to day Association expenses, such as keeping everyone informed on issues concerning the Association, insurance, other dues/subscriptions and office supplies. With our latest push for memberships we have 35% of the total property owners as members... Thank You.

Membership donations (over and above dues) is used for DNR Grant purposes or if there is a shortfall in dues. Volunteer hours go directly against our DNR Grants, these are very important to keep our finances in check. If we do not have enough volunteer hours, the expenses to vendors, comes directly out of our checkbook.

As you know, we have been selling raffle tickets to help offset expenses. We would like to see the proceeds go against our DNR Grants because we are short on hours, but other uses could be available based on discussion.

We desperately need you to enter in all time you have spent either boating along the lake shore or for pulling weeds from around your dock into our Volunteer page

at [https://tradelakeassoc.org/?page\\_id=162](https://tradelakeassoc.org/?page_id=162). Think about the entire year and what you have done- it counts! These hours are needed to meet DNR Grant requirements to cover the Association's cost of treating the Eurasian watermilfoil and Curly Leaf Pondweed that was done on our lakes in 2019. It's super easy to enter your time but if you prefer, you

If we don't get these hours we have to come up with the money to meet our commitment. **\*\*You do not need to be a member of the Association to enter Volunteer Hours!**

Instructions for entering your time:

1. Go to [<https://tradelakeassoc.org>], Select [Volunteer Hours] from the Menu across the top of the page
2. Enter Name, email, the lake you were on, date, and hours worked.
3. For Task Completed, there are some common tasks listed at the top of the drop-down list:
  - a. LMIS – Inspect Around Dock/Lake for Curly-Leaf Pondweed\*\*
  - b. LMIS – Inspect Around Dock/Lake for Eurasian watermilfoil\*\*  
\*\*These can be used when removing any weeds from around docks or when driving around the lake provided you are looking for invasive species at the same time.
  - c. LMIS – Fall Dock Inspection and Weed Removal (Zebra Mussels, Invasive Plants)
    - All Weeds must be removed prior to pushing the dock back into the water every Spring.
  - d. E – Boat inspection when Removing Boat at the Landing or launching boats in the Spring
    - Enter 30 minutes for each time and remove all weeds from boat and trailer – it's the Law now in Wisconsin.
4. Additional Comments: Please enter a brief description of the work performed; such as, "Looking for invasive species".
