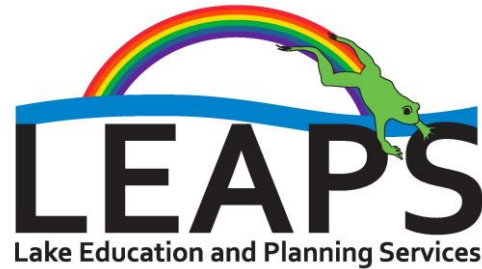

Dear Trade Lakes Property Owner,

The Round Trade Lake Improvement Association (RTLIA) is working to improve their understanding of what lakeshore owners on the Round Trade Lakes care about and would like to see improve. Your responses to the questions in this survey will be used to inform the RTLIA on what about your lake matters most to you and how the RTLIA can help you improve it. This survey asks questions that will help evaluate the current level of engagement of property owners in lake improvement activities, as well as questions on how to increase participation in additional lake improvement projects.
